Gfi Informatique announces the acquisition of the French company, SIS, the leader in emergency management software. SIS has notably developed two solutions that dominate the French market. The first is an emergency call regulation solution used by the SAMU, the French emergency services operator. The second manages the fire brigade's alert, operational management and decision support systems.

More recently, building on its experience, the company has also developed an alert and emergency operational management solution for sensitive sites, such as "Seveso" sites, including public transport (railway stations, airports, etc.) and, more generally, for all utilities.
